WHEREAS, as a result of a property tax foreclosure proceeding, Forsyth County currently owns property located on Booker Street, Winston-Salem, N.C. and further identified as Parcel Identification Number 6846-12-9708.00, for which the County has no use and wishes to sell to the highest bidder; and

BE IT FURTHER RESOLVED that the Clerk to the Board is hereby authorized and required to collect the bid amount of Christopher D. Casey and a deposit of five percent (5%) of the bid amount of any subsequent qualifying increased/upset bid.

BE IT FURTHER RESOLVED that the County Manager is hereby authorized to publish a notice of the said offer as required by N.C.G.S. 160A-269 and to re-advertise the offer at any increased/upset bid received until no further qualifying increased/upset bids are received.

BE IT FURTHER RESOLVED that Forsyth County may at any time reject any and all offers.
