#### REQUEST

Text amendment proposed by Planning and Development Services staff at the request of the Winston-Salem City Council to revise chapter B of the *Unified Development Ordinances* (UDO) to amend the various permitted uses allowed within zoning districts (UDO-263).

#### **BACKGROUND**

At the December 1, 2014 City Council meeting and again at the January 20, 2015 Council meeting, questions were raised by Council Member MacIntosh about the appropriateness of some permitted uses in various zoning districts. Also at the January 20<sup>th</sup> Council meeting, Council Member Besse requested that Planning staff specifically review the uses allowed in the IP (Institutional/Public) district. Subsequently, Planning staff reviewed all zoning districts and the permitted uses allowed within them. Staff compiled a list of potential revisions that would remove permitted uses from zoning districts where they did not appear to be appropriate.

Planning staff presented a comprehensive list of proposed changes to the Community Development/Housing/General Government Committee during their April and May meetings. Subsequent to said meetings, staff has revised the list of changes to reflect comments made by Council Members during the discussion, and the Committee agreed that these proposed revisions should go forward as a UDO text amendment.

#### **ANALYSIS**

The proposed changes to the Permitted Use Table serve as a periodic refinement to ensure that the UDO continues to function adequately. Many of the proposed changes remove land uses that are: (1) not compatible with the purpose statement of the underlying zoning district; or (2) are not compatible with residential properties that are typically located near the zoning district permitting said use. Several other revisions bring the approval process for certain uses in-line with other similar uses.
