On October 19, 2015, the N.C. Department of Health and Human Services allocated State Adult Day Care Funding to Forsyth County in the amount of \$162,576. This funding exceeded the original County Budget for Fiscal Year 2015-2016 by \$3,621. These funds assist in providing an organized program of services during the day in a community group setting for the purpose of supporting the personal independence of older adults and promoting their social, physical, and emotional well-being. These funds are 87.5% State and Federal. Forsyth County is responsible for providing a 12.5% match.
