**Meeting Called to Order**

A regular meeting of the Forsyth County Board of Elections was called to order in the second floor Board room on Tuesday, November 30, 2021 at 5:00 p.m., Chairperson Durrah presiding.

**Board Members in attendance:** Chairperson Robert Durrah, Secretary Catherine Jourdan, Member Chad Doomy, Member Alfred Harvey; Member Adam Draper- not present

**Staff Members in attendance:** Director Tim Tsujii, Deputy Director Michelle Bobadilla, Adam Clark, and Kimberly Stuck

**Pledge of Allegiance**

Chairperson Durrah led the Pledge of Allegiance.

The Board began discussion for the One Stop Early Voting Plan; Secretary Jourdan proposed for consideration of six (6) sites, including either Mazie Woodruff or Brown Douglas Recreation Center with two Saturdays and one Sunday; Member Doomy proposed five (5) sites with two Saturdays and one Sunday. Chairperson Durrah requested additional statistical information for both proposals. Member Doomy moved to table the discussion; Member Harvey seconded; **Motion carried 4-0.**
